
Competent Authority has approved to categorize the following empanelled Hospitals as Zonal Hospitals where CHSS beneficiaries can get the walk-in medical facilities without any referral letter with the help of Health Passbooks, which are being issued to all the CHSS beneficiaries of BARC(V).

- i. M/s. R.K.Hospitals, Gajuwaka, Visakhapatnam.
- ii. M/s. Kala Hospital (P) Ltd., Dwarakanagar, Visakhapatnam
- iii. M/s. Talasila Super Speciality Dental Hospital, Gajuwaka
- iv. M/s. Usha Prime Multi Speciality Hospital, Anakapalli
- v. M/s. Surya Teja Hospital, Atchuthapuram

General guidelines to be followed w.r.t to Health Passbooks are enclosed which may be complied with to ensure smooth operation of CHSS facility.

As Health Passbooks are now ready for issue, all CHSS beneficiaries are requested to collect the same from Administration between 10.00 hrs to 13.00 hrs and 14.30 Hrs to 17.00 Hrs from 04.09.2018 onwards.



GUIDELINES FOR THE USE OF HEALTH PASSBOOKS BY CHSS BENEFICIARIES

- 1) Individual Health Passbooks will be issued to all the CHSS beneficiaries of BARC(V).
- 2) CHSS beneficiaries can directly visit Zonal Hospitals without any referral letters for availing Out Patient treatment only by presenting CHSS Card and Health Passbook. No treatment can be availed without the Health Passbook except in case of emergencies.
- 3) CHSS beneficiaries visiting Multi Speciality Hospitals shall however continue to obtain referral letter from the officers who are authorized to sign referral letter. However, they will carry CHSS card and Health Passbook also.
- 4) Prescription by Doctor (AMAs, Zonal Hospitals & Multispecialty Hospitals) including investigations, if any, shall invariably be entered into Health Passbook only.
- 5) Carry Health Passbook to all the empanelled Hospitals / AMAs and collect the same, immediately, after the registration at Hospital / prescription by the Doctor concerned / Medicines are issued.
- 6) Check the validity of the Health Passbook and get renewed before its expiry.
- 7) Keep the Health Passbook in safe custody and do not allow any unknown / unauthorized persons to access the same.
- 8) Tearing / duplicating / Colour Xeroxing of Health Passbook shall not be resorted to.
- 9) In case of loss of Health Passbook, new books will be issued on payment of Rs. 300/-. However, the loss of Health Passbook should be notified to BARCF, Vizag immediately alongwith police FIR.
- 10) Surrender the Health Passbook of the beneficiaries, immediately, in case the beneficiaries become invalid to avail CHSS facility such as children getting married / gainfully employed / attaining the age of 25 years, exceeds income ceiling of parents / other dependents as the case may be.
